Privacy Policy

This privacy policy sets out how Roger Hyde Limited (RHL) uses and protects any personal data/information received and applies to all services offered by RHL.

Should we ask to be provided with certain information by which an individual can be identified (to include contact numbers and email addresses), then this information will only be used in accordance with this privacy statement.

What we collect and how we collect it

Personal data is a prerequisite for RHL entering into employment, customer and supplier contracts. We may collect personal identification information from users in a variety of ways, including, but not limited to:

We will collect personal identification information from Users only if they voluntarily submit such information to us. Please note non-personal identification information may be collected when Users interact with our website.

The following confirms the type of personal identification information we will collect:

- demographic information such as address and postcode, preferences and interests.
- other information relevant to customer surveys and/or offers.

What we do with the information we gather

We require this information to understand your needs and provide you with a better service, in particular, for the following reasons:

- Processing for the purposes of customer orders/sales.
- Customer service and consultancy.
- Internal record keeping: all information is updated and kept on our database to allow us to keep a record of any work quoted for or undertaken on your behalf.
- Communication & Marketing: we may periodically send promotional emails about new products, special offers or other information which we think you may find interesting using the email address which you have provided. We may also use your information to contact you for market research purposes.
- Products & Services: we may use the information to improve our products and services, including customising our website and/or database.
- Statistics & Analysis.

Sharing personal information

The information may be shared with third parties where required to do so by law and where it is necessary to administer the contract entered into with you. Security

We are committed to ensuring that all information is kept securely. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect.

As a company we use the services of an IT Support company to ensure that we have up to date security and antivirus software to best protect us from any online security breach. We regularly update all software used across the Company to ensure that we have access to the best technology available/applicable, with employees using two-form authentication to access our systems.

We regularly review information held on our database. Any e-marketing undertaken always allows for an option to opt-out of further communication from us and following notification of opting-out, our records are immediately updated and personal information deleted as appropriate.

Website and use of cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.


We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website to tailor it to our customers' needs. We only use this information for statistical analysis purposes and then the data is removed from the system.
